¹ AIMCo received notification on March 3, 2023, from the index vendor-S&P/Morningstar that the indices (S&P/LSTA Leveraged Loan Index ("LLI") + S&P European Leveraged Loan Index ("ELLI")) that make up AIMCo's Private Debt and Loan Product benchmark had a technical error in the calculation of accrued interest for some securities dating back to June 25, 2022. This error will not impact returns but will impact excess returns for PD&L and Total Fund. Once updated index values are available from the vendor, the impact to benchmark returns and excess returns will be determined.
