**3.1 Shortened Life Expectancy**

The ALAPP Corp. VP, Pension Policy and Funding, provided an overview of the report. There was discussion about the definition of shortened life, the current wording of the *Employment Pension Plans Act* (EPPA) in regards to this provision, the data on how often this situation may occur, what other plans do for this situation, if APS would be able to track and report occurrences and the definition of licensed medical practitioner.

**MOTION AL16:11:02** That the Board recommends that the Board of Trustees makes a recommendation to the Minister to amend the LAPP Regulation to include provisions consistent with those required under the Employment Pension Plans Act related to the unlocking of pension benefits due to considerably shortened life expectancy.
