



**3.2 Heartland Housing Application**

- (1) Pioneer Housing and Fort Saskatchewan Foundation be removed from the LAPP Regulation AR 366/93 Schedule 2 Part 1 as participating employers in LAPP; and
- (2) Heartland Housing Foundation be added to the LAPP Regulation AR 366/93 Schedule 2 Part 1 as a participating employer in LAPP.
